MINUTES OF THE 2021 ANNUAL MEETING

November 14, 2021

The Annual Meeting of First Congregational UCC, Dubuque, Iowa, was held in the church sanctuary on November 14, 2021, following the 9:30 a.m. worship service.

Moderator Josh Weidemann called the meeting to order at 10:28 a.m. A required quorum of 37 members was met with 55 members in attendance.

Otto Krueger moved that the minutes of the November 15, 2020, Annual Meeting found on pp. 2-3 of the Annual Report be accepted as submitted. Following a second by Barb Collins, the motion passed.

Moderator Josh Weidemann pointed out the Church Clerk's report on pp. 3-4 in the Annual Report. There were no questions.

Old Business: No Old Business.

New Business:

- a. Moderator Josh Weidemann pointed out that the Moderator's Report is attached to the Annual Report on pp. 5-6.
- Boards and Committees Josh pointed out these reports in the Annual Report on pp. 8-16. There were no questions.
- c. Nominating Report Josh presented the list of nominations for 2022 found on p. 17 of the Annual Report. There were no additional nominations and no questions. Phil Ruppel made a motion to accept the report. Following a second by Karen Steele, the motion passed.
- d. Josh drew attention to the Church Organization Chart on p. 18 and the 2022 Church Administration Schedule (subject to change) on p. 19.
- e. Josh presented the proposed church 2021 by-laws changes found on pp. 20-39 with red-line changes and a "clean" version in the report. Some language did not translate. There is a corrected, attached version.

*Karen Steele questioned why delegates to the Iowa UCC annual meetings and to the Eastern Iowa Association meeting should fall under two separate committees – Deacons and Missions. The by-laws should be corrected to reflect that all delegates should fall under the Board of Missions and Social Concerns.

*Changes in by-laws language will formalize what is already in practice and make us officially a UCC church that is "Open and Affirming."

*Merle Santjer explained that the Trustees now will have subcommittees – HR, buildings and grounds, and finance. The HR subcommittee (currently, Steve Felsted, Jeff Mozena, and Merle) will review staff job descriptions.

*Sharon Sinton questioned moving pastoral oversight from Deacons to HR. She also questioned who would be responsible for pulpit supply – that will be the responsibility of the Executive Team.

Bill Ross made a motion to accept the 2021 by-laws revision. Following a second by Chuck Harris, the motion passed. Bill emotionally expressed great appreciation for the efforts that have moved us to be officially listed as Open and Affirming with the UCC. He reminded us that it's been a long journey – started by his wife Nancy 20 years ago when the church voted to become "Open and Welcoming" to all.

- f. Merle Santjer presented the new Investment Policy found on pp. 40-45. He indicated we have never had a formal policy on how to manage current and future donations. The investment policy has been written in "donor language" and will outline and provide guidance going into the future. Following a motion by Sarah Ortmann and a second by Chuck Harris, the motion passed.
- g. George Davis, Treasure, presented the 2022 budget found in the Annual Report on pp. 46-48. The \$478,580 budget is a balanced budget. George reported that we are in a very strong financial position thanks in part to the two PPL forgivable loans and the generous support of the congregation. Over all our investments are up. Our current pledge commitment is 5% ahead of where we were last year.

*Mark Sinton asked why the actual 2021 numbers were not reflected in the printed report. George didn't know why the omission occurred but said "we are \$75,000 to the good in actual activity through Oct. 31." Mark questioned the apparent shortfall of pledges but was assured that some do not pledge but give and those that use electronic deductions often don't fill out a pledge card but also give.

Following a motion by Karen Steele and a second by Danny Sprank, the congregation approved the 2022 budget.

Rev. Dr. Lillian Daniel offered a closing benediction.

Following a motion by Kirsten Weidemann, a second by Dick Steele, and approval by the congregation, the 2021 Annual Meeting was adjourned at 10:58 a.m.

"Teach me to do your will, for you are my God; May your good Spirit lead me on level ground."

ASSOCIATE PASTOR REPORT

This has certainly been a year full of twists and turns and unexpected challenges! As I am reflecting back on the year, I am amazed by everything we have been through and how resilient we are as a congregation. As this year began, we were still taking our first steps out of existing in an active pandemic and trying to rebuild after several years of Covid 19 restrictions. Just as it was starting to feel like we were getting our footing, we learned that the north wall was unstable and that our sanctuary was condemned!

Though this was certainly a difficult situation, our congregation didn't miss a beat. We joined with our neighbors at St. Lukes and then found a temporary home at Steeple Square. We began worshiping in the opulent and beautiful sanctuary space, however the magnificence of the space did not make up for the poor sound quality of the space. We have relocated worship to a cozy conference room in the basement of Steeple Square where everyone can hear what is going on. What the future holds in regards to our sanctuary and worship locations is not exactly clear. However, we are taking things one step at a time and appreciating each Sunday we are able to worship and fellowship with one another.

In February, we learned the bittersweet news that our Senior Pastor, Rev. Dr. Lillian Daniel, had felt the call of the Holy Spirit to take on the role of UCC Conference Minister for the state of Michigan. We were sad to see her go but also rejoiced with her on this new and exciting opportunity to grow in her Ministry and God's call for her vocation. As we prepared for her departure, I took the steps necessary to acquire authorized Lay Ministerial Standing and agreed to serve this congregation as the search began for a new Senior pastor. I have learned so much and been received so warmly by our congregation. It has truly been amazing to have the opportunity to follow this calling, learning and growing in my role as Associate Pastor.

Because of the logistical talents of our Church Business Manager Nikki Ketchum and the hard work of our custodian Tom Bodnar, we have been able to continue to hold our Wednesday night programming in the education wing of our building. We moved the family supper to one of the upstairs classrooms and transformed another classroom to accommodate Kids Club. This programming year, our older youth were thrilled to have the use of their youth room again. One of the highlights of the year was our older youth event at Offshore Resort. It may have rained but fun was had by all! We look forward to scheduling an event for the younger youth. We are also blessed to have Kirsten Weidemann on staff running Kids Club and Andrew and Rachel Kitzinger back as our youth ministers. We bid farewell to Hannah Von Mulert and wished her Godspeed, and we immediately put our new member and accomplished musician Jill Freebolin to work as our new choir director! Joanne Wright continues to be our music director and we are blessed by their gifts as well as the gifts of our talented choir and musicians every Sunday.

This year may not have gone as planned or maybe as we had originally hoped, however if the past few years have taught us anything, it is that our plans are really an illusion. God, however, will always be working through the plans that we have made and the plans that have been broken. God will always show up, as we have seen this past year, sometimes it is in the most unexpected ways.

BOARD OF TRUSTEES REPORT Merle Santjer

Thanks to the "pillars from the past", your vision for the future has kept us strong! As I reflect on the year to date of 2022, I can only be thankful for our members and leaders of the congregation over the past decades. The current Trustees and congregation members are grateful for your dedication to our church's mission to be a "Church with a heart of the City". The following is a summary of the Trustees work for the congregation so far in 2022:

January- Breakdown of Trustees to serve on sub-committees: Building and Grounds, Human Resources and Financial. The purpose of these subcommittee is to improve discussion and decision making and recommendations to the trustees. Approval of construction management with Gronen Restoration was signed.

February- Review of possible changes in church worship location due to North wall condition/repairs needed. Contract with Berghaus Pipe Organs reviewed and signed. Church social room to be primary backup for worship. Senior Pastor Lillian informed Trustees of her decision to become UCC Conference Minister of Michigan.

March- Reviewed transition paperwork for Senior Pastor Lillian Daniel. Reviewed Origin contract as to completion of all work and discussion of contract with WJE out of Chicago.

April-Discussion on moving to Steeple Square for temporary worship location. Reviewed timeline of WJE contract: Phase 1-Investigation Stage, Phase 2- Preparation of documents, Phase 3- Construction period. Shared copies of separation agreement, transitional organizational chart and new job description for Pastoral Associate Kaity Kemp. All documents agreed upon and approved. Reviewed plans for farewell reception for Senior Pastor Lillian Daniel. The Search Committee provided an update.

May-Review of work and contracts: Berghaus Pipe Organs, Bovard Windows, WJE, Gronen, all contracts approved. Search committee provided an update. Future Capital Campaign discussion once we have a report from WJE on north wall repair costs.

July- Reviewed staff reports on the need to increase Pastor Kaity's hours up to 30-40 a week, Jill Heitzman was hired to replace Hannah von Mulert as Choir Director. Review of reports by WJE and Gronen on the North Wall project. Search Committee update. HR Subcommittee: reviews scheduled for Nikki and Pastor Kaity as well as job descriptions reviewed and updated.

September- Pastor Kaity provided an update on her work as pastor. WJE report reviewed. Trustees appreciate the thoroughness of the report. Search Committee update. Financials: Sub committee met to work on 2023 proposed budget. God has a bigger plan for our church, than we might currently have.

October North wall update reviewed on stabilization report provided by WJE to Gronen with an implementation stabilization plan yet this Fall. WJE working on project bid/repair documents. Reviews and job descriptions update from HR subcommittee. Approved draft of 2023 budget.

A personal Thank you to fellow trustees, Pastor Kaity Kemp, Church Business Manager Nikki Ketchum and all church staff for your dedication and unwavering service to the church in 2022. Our congregation is blessed with your daily work. As trustees, we continue to manage the mission of the church., Thanks to our congregation for generous and faithful financial support.

As Steve Felsted, member of Trustees stated during his mission moment to our congregation.. Our North Wall may be weak but our church is strong!

BOARD OF MISSIONS & SOCIAL CONCERNS Melissa Ellis, Co-Chair

It seems our ability to face adversity is being tested once again in 2022! As Covid-19 is still a daily concern in our community so too is the safety of our church home. The lack of structural integrity our north wall has again made us adapt our mission to our current environment. As another year comes to close, we learned to adapt to the challenges we've faced to meet our goals and be thankful for all that has been achieved.

Given the challenges we've all faced, our goal for 2022 was to continue to support our local, national, and international missions. As we have learned over the last few years, the only thing we can count it is unpredictable. Therefore, the Board of Missions voted unanimously to assess our budget and giving periodically throughout the year. We felt this would give us the ability to continue to support those organizations that we have in the past, but also have the flexibility to support needs that arise as the year progresses.

Because of the safety concerns surrounding our building the Café Ministry has been put on hold, but we continue to financially support those organizations that have stepped in to help our guests get a hot meal on Thursday evenings. As this was our biggest outlet for the Hygiene Pantry, we have been working to find other outlets to continue with this mission.

Locally, we continue to give financial support to St. Stephen's Food Bank, DBQ Food Pantry, St. Mark's Youth Enrichment and the Dubuque Rescue Mission. Our generous congregation also brought many, many pounds of carrots to support the Food Pantry request for the Easter season. We've also donated a large quantity of winter socks and gloves to both the Rescue Mission and Resources Unite. This will help keep toes warm over the cold Iowa winter!

Angie's DayCare sent an application directly to the Mission Board requesting daycare specifically children's dinnerware, a small pantry for snacks and non-perishable food, highchairs, diapers, and clothes. This center assists low income children, several that are in the department of human services care due to neglect. The board was able to meet all their requests and intends to continue to support them by having a snack drive – "Treats for Tots" - to stock the pantry.

We were able to support regional needs by contributing to Mobile Independent, a group that refurbishes electric mobility chairs and provides them with the hope that they will be returned to the group to be put back in service when they are done using them. Along with Mobile Independent, we supported Afghan refugees in Platteville, WI where our support helped set up the refugees with housing, employment and schooling so they can be active and engaged members of their community. We also assisted a very special family that lost their entire home in a fire by providing much needed household staples and items for their four children.

On the global front we voted to support Zambia Foundation, which helps schools and teachers with providing tools and resources for children to learn in a safe setting.

Annually, we look at how to share our gift allocations between local, national and global. We adapt these allocations as needs change. This year we continued to support the Church's Wider Mission (OCWM) with both Iowa and National Conference support. Member Emergency Fund and the remaining amount of \$27,400 remaining funds to be used locally, nationally and globally, below is the list of 2022 allocations:

The Café Ministry faced many challenges in the past year. In November of 2021, our Café coordinator Nikki Ketchum had to reduce her duties after emergency surgery on her neck and spine making her unable to do several tasks. Tami Ryan stepped up and jumped in to fill these duties and take on the lead role of our meal going forward with assistance from Nikki Ketchum.

An engineering company was hired to inspect our North wall and found structural problems. The firm deemed the social room and kitchen unsafe for our volunteers and guests. The Café Ministry tram was able to make some fast changes, the committee members began to cook at Tami's home and other preparations and bagging were done in the lower level in the church building as we switched to giving to-go meals from March 10 to June 9.

Once the engineers asked that we not be in the social room or kitchen, we were left with no option but to suspend Cafe meal at our location. The Dubuque Rescue Mission immediately stepped up and began serving the Thursday night meal in our place until we are able to return.

The Café Ministry continues to provide financial support for the program as well as encouraging our volunteers to assist at the mission during this time. Once we are able to have access to the kitchen and social room, we will return to cooking and serving our biggest mission. We deeply miss our guests, our volunteers and serving to all our neighbors in need.

The Café Committee consists of the following dedicated members: Tami Ryan and Nikki Ketchum, Café Coordinators, Diane Heiken, Mary Weck, Shirley Grall, Charlie Daoud, Dan Schumacher, Marty McNamer, Joanne Wurtz and Terry Wilson who has served on the committee since the beginning 28 years ago!

We also continue to have several other dedicated members and community volunteers that assist on a regular basis who we could not do our mission without their dedication that will return with us.
